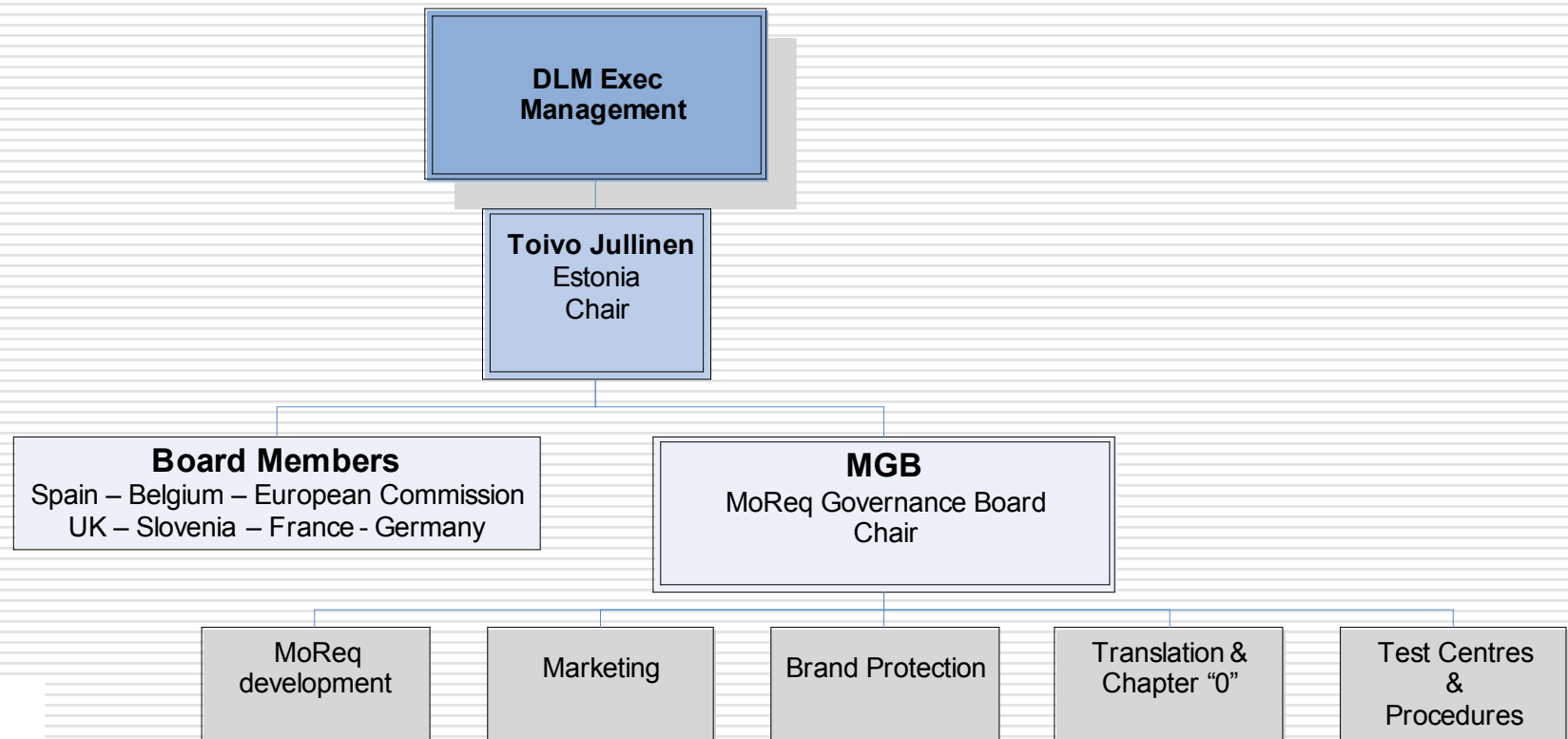

MoReq

- MoReq
 - Translated into Portuguese, Spanish, French, Slovenian, Italian, Czech, Hungarian, Russian and Croatian.
 - Incorporated into National Standards in Norway, UK, Germany, Finland, Holland
- MoReq 2
 - **Catalan:** unvalidated translation expected
 - **Czech:** status uncertain.
 - **French:** unvalidated translation published; Chapter Zero validated.
 - **Hungarian:** translation project under way.
 - **Korean:** translation project under way.
 - **Russian:** two independent unvalidated translations published.
 - **Slovenian:** translation project under way.
 - **Spanish**

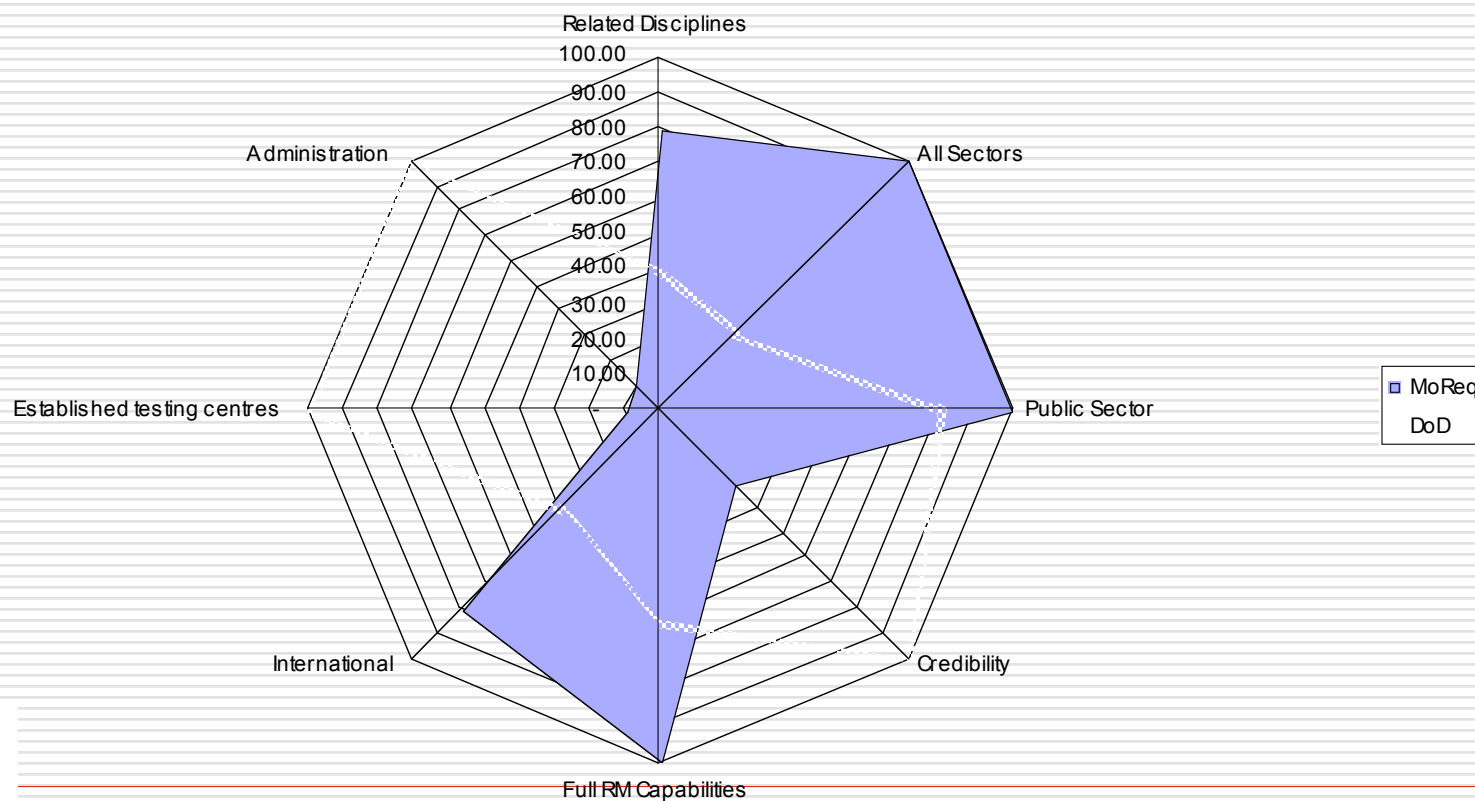
